a. Universal and correct wearing of <u>masks</u> ;	All non-vaccinated staff and students will be required to wear masks while in the school building, except for during breakfast and lunch. The school will provide reusable and disposable masks to all students, guests, and staff members.
<ul> <li>Modifying facilities to allow for <u>physical</u> <u>distancing</u> (e.g., use of cohorts/podding);</li> </ul>	Markers are in the hallways and common spaces to indicate appropriate social distancing. While students are in the classroom, they will sit at a single desk with a plexiglass partition.
c. <u>Handwashing and respiratory etiquette;</u>	Schedules have been created to allow additional time for restroom breaks and handwashing. Hand sanitizers stations will remain in each classroom, hallways, and other common areas. All students will receive a tutorial at the beginning of the

	school year by the school Nurse demonstrating proper handwashing Schedules have been created to allow for additional time for both restroom breaks and handwashing techniques and hygiene. Signage remains in the hallways, classrooms, restrooms, and other common areas that promote everyday protective measures and how to stop the spread of germs.
d. <u>Cleaning</u> and maintaining healthy facilities, including improving <u>ventilation</u> ;	Cleaning, sanitizing, and disinfecting will occur daily on a developed schedule every two hours for drinking fountains and restrooms. Cleaning, sanitizing, disinfecting, and ventilating will occur in learning spaces, drinking fountains, restrooms, hallways, and common areas at the end of each day. The school uses sanitizing and ionizing equipment daily to clean the facility. We also use cleaning solutions which meet OSHA & CDC requirements for COVID-19 prevention.
e. <u>Contact tracing</u> in combination with <u>isolation</u> and <u>quarantine</u> , in collaboration with the State and local health departments;	We will continue to collaborate with state and local health departments, to the extent allowable by privacy paws and other applicable laws, to confidentially provide information about people diagnosed with or exposed to COVID-19. We will notify, to the extent allowable by applicable privacy laws, teachers, staff, and families of students who were close contacts as soon as possible after they are notified that someone in the school has tested positive. In the event of a positive case students and staff will be asked to continue to stay at home and stay away from others (isolate). They may return to school / work no sooner than 10 days have passed since the onset of their symptoms, or since the date of their positive test (for persons without symptoms). They also must be fever-free for at least 24 hours, without having taken fever reducing medication, and have an improvement in their symptoms.

	Allegheny County offers through community partners and Curative, Inc. Insurance is not required. Through the program, families have access to a variety of options for testing including community-based testing, walk-up van testing, testing at the Federally Qualified Health Centers, and a McKeesport Drive- Thru test site.
g. Efforts to provide <u>vaccinations to school</u> <u>communities</u> ;	We will be participating in the COVID-19 school testing program lead by the Pennsylvania Department of Health (DOH). The school testing program is expected to include several options for testing, including rapid tests, at no cost to the school or families for the entire 21-22 school year.

Appropriate accommodations for students with disabilities with respect to health and safety policies; and</li> </ul>	In the event a student(s) or staff member(s) have been identified as high risk for severe illness, they will be permitted to learn or work remotely upon request to not endanger their health and wellbeing.
<ul> <li>Coordination with state and local health officials.</li> </ul>	The school notifies the Allegheny County Health department of any instance where there is a positive case of COVID-19 in the school or a student or staff member has been in contact with someone who has tested positive for COVID-19.
